#### ANNUAL MEETING August 27, 2015

# The Annual Meeting of the residents of the Borough of Woodmont was held on Thursday, August 27, 2015.

#### **Meeting Opening**

The meeting was called to order by Warden Edward W. Bonessi, Jr., at 8:04PM.

In attendance, thus meeting the requirements for a quorum with at least thirty Woodmont residents in attendance were a total of forty five-registered freeholders in attendance, and two non-voter residents.

#### **Pledge**

The Warden of 83 Beach Ave led the group in saluting the American flag and in reciting the Pledge of Allegiance.

#### **Introduction of Officials & Staff**

Warden Bonessi of reviewed ground rules for the meeting and then introduced Burgesses and Officers.

#### **Approval of 2014**

Warden Bonessi of reminded everyone that the minutes are a summary of what happened. The minutes were reviewed by Borough residents. A Motion to approve the minutes was made by Frank Grazioso of 27 Hawley Ave. St., seconded by Mike Krauss of 77 Hawley Ave and the Motion carried unanimously.

#### New Business / 47 Freeholders in Attendance

Pat Del Vecchio of 56 Mark St said that she has not spent the budgeted line item for the Beautification Committee for the past three years. Pat Del Vecchio said that she spent \$2253 of City Funds and collected a total of \$2520 giving a net proceed of \$274 back to the general fund and have not spent any Borough funds to date. I take your money very seriously. Christopher Schmeisser, Finance Burgess, explained how the line are accounted for by the book keeper.

Doug Roberto of 14 Village Rd is very unhappy as something went down. He says that he runs a support group, and Joe Roger's made an arrangement for \$15/week for custodial services. Unfortunately the lot was not plowed for a meeting and Joe Rogers did not show on a few occasions. At the end of the last meeting Jim Freda told me the fee was \$30 per meeting something I had not been informed about. I checked the minutes of the last meeting before the meeting where a fee was only discussed and a resolution had not been passed. Also, we are accused of using Borough office equipment and were told we broke some it. We are support group, one of three on the east coast and the members are disabled and collecting enough money to cover the custodial expenses is difficult. Warden Bonessi of responded that the arrangement with Joe Rogers was for less than what he had told Joe Rogers that it should be, either \$25 or \$30, and going forward, the fee will be increased at 128 Kings Highway. Warden Bonessi apologized for any misunderstanding.

Dan German of 114 Beach Ave thanked the Board for all their hard work that can be a thankless one. Dan German is concerned and said that the issue with the sand along the Crescent is an issue we are always struggling with and hopefully will get some headway after meeting with state representatives just before this meeting. There are three phone poles that are used to supply one light down at the Crescent that should be removed and replaced with a solar light to help improve the look and feel of the area. Concerning the bump-out, we should remove the curbing and replace it with brick and leave all flat leaving it maintenance free.

Dick Austin of 14 Village Rd thanked the Board for their efforts, it's not easy, and we strive to do better. I get a few calls and you have to return calls and get back to people. A discussion followed with Warden Bonessi.

Dick Austin of 14 Village Rd wanted to know what kind of garage the Board was planning to build behind 128 Kings Highway. Warden Bonessi of responded that it will be three bay garage that will meet all Borough requirements. Dick Austin responded that we got along with a two bay garage for the past 30 years.

Dick Austin of 14 Village Rd Motioned that if the Borough decides to build a new garage behind 128 Kings Highway, that it be limited to two bays with electric service, suitable

for the police car and Borough public works, seconded by Rich Cary of 103 Hawley Ave and the Motion failed with one in favor.

The discussion concerning the new garage.

Christopher Schmeisser, Finance Burgess, explained the budget line items for the upcoming year in terms of capital improvements to include monies for sand replenishment, and to finish the new Borough hall to include, a new garage, additional paving at 128 Kings Highway for parking, and \$40K for a new roof. We currently have a balance of \$114k in the Borough Reserve Account with the sale of 31 Clinton St with an estimated value of \$170k will increase the Borough Reserve Account to \$264k - \$40k for the new roof to a balance of approximately \$224k. The \$224k would be dedicated to sand replenishment, to pave a parking lot, and for the new garage. Christopher Schmeisser continued to say that he is an advocate for sand replenishment and thanked Warden Bonessi and Senior Burgess Barrett of 32 Hawley Ave for their extreme effort to get FEMA to reimburse the Borough after reneging their commitment to pay for replenishing the sand after Storm Irene. Since the city of Milford will no longer replenish the sand we must maintain the beach to keep our contract with the Army Corp of Engineers. After Storm Sandy, the Army Corps of Engineers approved \$2.3M to rebuild the beach.

Warden Bonessi of spoke out against the Motion stating that we had two major storms in an eighteen month period and for the first time in his family's 56 years residency in the Borough there was evacuation due to Storm Sandy. When leaving to evacuate with my family, a neighbor called wanting to know where the shelter was, and I responded that the nearest shelter was Johnathon Law High School. My neighbor asked why not Borough Hall or Fire House No. 5, and then I realized we needed a shelter for Woodmont. I have meet with city officials concerning a shelter for Woodmont that said we need to be a point of distribution (POD) that will require us to have a flat area to receive pallets of water, tarps, etc., during a storm emergency. The garage will be used to store barriers, barrels, the police car, and storage for our own materials, and the WRCA only uses a small amount of space. Jim Mallico has also approached me wondering if it would be possible to store his pay loader in the garage before a storm for snow removal. Please do not handicap me by passing this Motion, it is very important to have a three bay garage.

Dan German of 114 Beach Ave wanted to know the cost of the three bay garage, and Warden Bonessi responded that a metal three bay garage is estimated at \$90k. Warden Bonessi said that the garage would not be paid with reserve account monies but would be funded by the sale of 31 Clinton St, the sale of tax liens, or a possible second STEAP grant.

Greg Field of 173 Kings Highway said that the difference in the cost between a two and three door garage is not that great. Greg Field said that he feels that a metal garage will not be very appealing and that a wood framed structure would be more aesthetic.

End of discussion concerning the new garage.

Greg Field of 173 Kings Highway said he would like to comment on the wall that is falling apart on Crescent Beach and that we need additional lighting at night since many people walk along there in the evening and someone could easily walk off the sidewalk. Warden

Bonessi responded saying that we had a lost opportunity with the State of CT this year for sand replenishment along the Crescent Beach area if the private land owners had agreed to the plan to have sand brought up from Stamford, which they did not. The City of Milford has a grant for a water front project to include Anchor Beach.

Greg Field of 173 Kings Highway complained that fisherman on 108 Beach Ave are using his port-a-potty at 96 Hawley and Dixon, where he is building a house, and that the neighbors are starting to complain. Warden Bonessi said he should lock it when not in use and to call the police if the fisherman try to use it.

Rich Shain of 136 Beach Ave said that Crescent Beach used to be a beautiful sandy beach 50 years ago. The infrastructure is falling apart, it is in really bad shape, and we need to add sand back to protect it.

#### Approval of Proposed 2016-2017 Borough Budget

Pat Del Vecchio of 56 Mark St Motioned to pass the Borough Budget, seconded by Dick Austin of 14 Village Rd, and the Motion passed.

Discussion concerning the budget.

Christopher Schmeisser, Finance Burgess of 5 Belmont St gave an overview of the proposed budget and how it was determined.

Chuck Rockwell, House Burgess of 28 Mark St Motioned to amend the budget to add back the line item Fire Co. / CERT for \$1000, second by Dick Austin of 14 Village Rd, and the Motion failed with 5 in favor.

Discussion concerning Chuck Rockwell's Motion

Chuck Rockwell argued that the money was needed to fund the CERT effort by the Fire Co. Christopher Schmeisser, Finance Burgess, responded that the Volunteer Fire Dept. will already have \$6k as of this year. John Barrett, Senior Burgess, said he is against the Motion, that he was behind bringing in CERT, that we are a Milford CERT not being our own nor do we have authorization to have a Woodmont CERT, which would be nice to have. The Milford CERT provides all the basic supplies through FEMA and we help facilitate the POD. John Barrett explained the process of how the POD works.

#### Adjourn

Warden Bonessi of 83 Beach Ave entertained a Motion to adjourn the meeting. Pat Del Vecchio of 56 Mark St Motioned to adjourn the meeting, seconded by Dan German of 14 Beach Ave and the Motion passed unanimously by voice vote at 10:19PM
