Report of the Tax Collector:

Tax Collector Lynn Foss said that \$10,000 came in from on-line tax payments. Notices of "Intent to Lien" will soon go out.

Report of the Warden

- Warden Bonessi reported that we have had lots of snow and we are about \$15,000 over on snow removal.
- The Southern CT Gas Company has made an emergency request for installing two miles
 of new gas lines. Some of our newer paved roads will be affected. The Borough did some
 extra snow removal to accommodate the gas company's equipment. We sent them a bill
 for \$7,200 \$7,500 for this.
- Results of a phone conference with the Mayor: If we can show that the affected streets
 for the gas lines dug up are only three years or less old, the city will pay for a total
 repaving, curb to curb. The Borough would like to do that. Warden Bonessi will call Chris
 Saley and the Gas Company. For now, cold patch will be one on the affected streets.
- Additionally, the Mayor is proposing a \$5,000 increase in our yearly grant. We have requested \$15,000. Some of the projects listed are sidewalks and the Belmont Street Groin. We need to have "shovel ready", engineer plans in place before making the request.
- August storm damage will be mostly reimbursed.
