# Lighting

Burgess Kish submitted the following summary:

# 10/10/16, 11/15/16 B. Kish communication with UI Account Rep Mike Stein.

- Bridgeport is first town to complete group re-lamp to LED. 10,600 lights. They chose 53 watts for main streets and 30 watts for side streets.
- UI is planning to install various style lights at their own pilot facilities but these are not started yet. Best to visit either Stratford or Bridgeport to see brightness and color. Its easy to tell wattage from ground level (large yellow LED labels 30, 53, 107 watt).
- UI's group re-relamping is done at no cost to the borough.
- Milford and Woodmont group re-relamping are scheduled together as one effort.
- UI is likely to approach Milford in 2017 Q3 or Q4, at which time Borough has approx 3 weeks to choose watts for each light. Execution of work is typically 2-4 months after selection of fixtures. When cities get bogged down with selection of fixtures or other construction issues, UI may leave them behind and go help another city.
- Okay to delete lights prior to execution.
- Okay to add new lights to be incorporated into the group re-lamping plan.

- After execution, UI will change fixture at no charge to higher watts if too dim
- After execution, UI will change fixture to lower watts if too bright, but will charge fee if done inside of first year.

11/18/16 B. Kish communication with UI "Lite-the-Nite" program manager Mike Miranda.

- UI offers two decorative styles, acorn and colonial, which would be mounted on decorative poles
- There are no instances of decorative lights installed on wooden poles
- wooden poles have cobra or mongoose head.
- cobra head is most ubiquitous, many watt styles, designed to face down with very minimal side lighting toward either curb.
- mongoose head is designed to be rotated and tilted as desired, which can be advantageous. But these start at 250w, really bright!
- decorative lamp poles like those at West Haven beach are owned by UI, not metered.
- decorative lamp poles like those in downtown Devon are owned by the city, and metered.
- Regardless of ownership, UI customer must excavate and install underground conduit. The difference in ownership affects who 1.) furnishes poles, pole bases, lamps, wire, 2.) provides all labor to set bases, poles and complete the wiring and 3.) maintains the poles and lamps.
- Approx value of bases, poles and fixture is \$2000; Thus 2000 x 16 = \$32,000 for 1500 foot of beach front, 100 feet apart.
- It is practical to execute any pole line project over time by extending its length year by year.

# 12/5/16 Discussion

- RK agreed to acquire the existing fixture data from city GIS maps and consult with JB for purposes of making wattage recommendations.
- RK agreed to document the dates and time spent on planning work associated with UI's LED group re-lamping project.
- The group discussed various ways to solicit borough input on lighting. No formal process for collecting and processing borough input was established.
