Report of the Tax Collector

• Clerk Guelakis swore in Lynn Foss as acting Tax Collector for the Borough of Woodmont.

Lynn Foss reported that we have received four additional payments since last month. Working with the bank to set up a lock box for tax receipts, and that the tax liens would be going out this week. Warden Bonessi again thanked Tina Della Vella for all her work in taking on this troubled area and bringing the train back on track.

Report of the

Warden Bonessi reported the following:

- That grass has been planted in the back of Borough Hall
- We are still working on the CO for Borough Hall, the coat hooks in the rest rooms have been hung too high and have to be adjusted
- We are going to be in the process of removing the old garage doors to be replaced by new double doors. Jim Mallico will be starting work this week to also include the court yard
- The paving around the Borough is to the credit of the mayor, for approximately two miles of paving, a joint effort between the Borough and City. The mayor has provided the Borough with \$2M in find services
- The Old Borough Hall, 31 Clinton St, has been sold. The building has been determined to be more deteriorated then originally determined by the new owner and he will have it torn down
- We are renting our old garage for up to one year until we build our new one
- Currently putting together the budget for our annual meeting
- Ed Rhodes from the Radio Club is donating his time and materials to build two 15 foot teak benches for the front of Borough Hall. Also, he will be putting us into flag compliance, and has helped in running conduit wiring for the new garage lighting and security cameras

• Mike and Katie Krauss would like to create a Woodmont Borough museum on the second floor while helping to turn our new Borough Hall into more of a community center. Donna Mallico is working on procuring an application.
