Report of the Tax Collector

Tax Collector Lynn Foss said that Adam Cohen has received approximately 27% of delinquent taxes owed to the Borough, he has collected \$22,822.75 out of a total \$82,101.07. The Borough grand list received by the city is \$213,326,810.
