- 2. I would add that the Borough will send out an "intent to lien" notice prior to filing the Lien with the city, and that all property owners will have 15 days to make payment prior to the Tax Collector filing a Lien with the City of Milford.

3. QDS sent us the "delinquent list", therefore I assume that all property owners can go on line to our database and see if they are "outstanding" in any payments.

Beautification Report by Pat Del Vecchio

Pat Del Vecchio reported that E and D Landscaping was contacted to add Rip Rap from Wall ST to Bonsilene ST to the existing Turf Masters account for spraying and to order 100 -125 creeping junipers and up to 50 yellow Rosa Rugoses for area from Devol ST at the point to Wall ST for planting in the fall as the Warden directed. She also passed around the plaque for the Donohue Family Bench Dedication stating that the bench would be built this week and would replace the most damaged bench along the shoreline

• Review Annual Budget

Burgess Schmeisser Motioned to accept the proposed 2016-2017 Borough budget, seconded by Burgess Barrett, and the Motion passed with Burgess Rockwell opposed with changes.

Burgess Barrett Motioned to reduce the Volunteer Fire Department budget by \$700, with no second, the Motion failed.

Burgess Schmeisser Motioned that the \$2,000 line item for the Volunteer Fire Department be dropped to zero since prior funds allocated have not been used, seconded by Burgess Barrett, and the Motion passed with Burgess Rockwell opposed and Burgess Wagner abstaining.

Burgess Schmeisser questioned the line item expense for the Woodmont Day Committee and that it is approved during times of need, i.e. due to rainy weather.

Burgess Schmeisser Motioned that the line item expense for the Woodmont Day Committee be put at zero dollars, seconded by John Barrett, and the Motion passed with Burgess Rockwell opposed.

Burgess Barrett Motioned to reduce the firehouse, 128 Kings Highway, costs to zero. After a discussion Burgess Barrett withdrew the Motion.

Burgess Schmeisser stated that the Police patrol line item had been reduced from \$40,000 to \$30,000 about two to three ago and should we consider an increase. A discussion followed and the 128 Kings Highway utility costs of \$4,800 was reduced to \$2,400 and the reduction of \$2,400 from the 128 Kings Highway utility costs was added to the Police patrol line for a total of \$32,400.

Authorization for COP Application Fee

Burgess Luysterborghs explained that a DEEP application fee of \$187.50 is required for acquiring our COP renewal. A discussion followed and it was concluded that the application fee would be charged to city funds.

Burgess Barrett Motioned to authorize \$187.50 for an application with DEEP to renew our COP, seconded by Burgess Kelley, and the Motion passes unanimously.

Freeholders II

Pat Del Vecchio of 56 Mark St. wanted to know the status of a parking study that she requested for Mark St. Burgess Kelley stated that she would email the police department again concerning the matter. Pat Del Vecchio questioned the beautification committee line item at \$3,000 and is the money that is coming through donations affecting expenses, a discussion followed.
